Objective of the RFP

Through this RFP, Shiv Nadar University invites proposals from competent firms for needs assessment in the educational facilities available in the selected geographies under Dadri Development Project. The project also complies with the indicators mentioned in the Sustainable Development Goal (SDG)-4, related to inclusive and equitable quality education and promote lifelong learning opportunities for all.

Detailed Activities

Scope of Work

- Understand the current scenarios in educational facilities and provide analysis of variations and challenges in a need assessment framework.
- Conduct a needs assessment study to understand gaps in educational institutions in 8 villages of Dadri region in Gautam Buddha Nagar
 - The education institutions to include: Anganwadis, Primary Schools, Upper Primary Schools, Secondary Schools, Senior Secondary Schools (Govt and Private), government and private colleges, ITIs etc.
- The needs assessment study should include assessment of
 - o Infrastructure availability, and condition of the same
 - Including seating facility, playground equipment, and other necessary equipment
 - Condition and adequacy of physical infrastructure
 - Sanitation facility
 - Educational material availability
 - Usage of ICT
 - HR availability
 - Capacity of HR including teachers
 - o Processes followed
 - o Student enrolment, attendance, dropout rate, gender wise enrolment
- Compare and benchmark the above list of assessment parameters against government regulations including RTE, building codes, and other benchmarks

Deliverables

- Prepare a needs assessment framework and suggest interventions to include the areas of gaps to be assessed in educational institutions
- Submit phase wise detailed work plan along with timeframe and responsible parties for this need assessment survey
- Approvals from government and administration of educational facilities to conduct the needs assessment study
- Finalize study methodology and approach including data collection methods and sampling strategy.
- Finalize data collection tools (questionnaire, checklist, guidelines etc) for the study in consultation with Shiv Nadar University team. The team will be responsible for pre-test and finalization of tools and techniques for the survey. The data collection tools will be in Hindi and English language.

- Engage qualified enumerators, train them on quantitative and qualitative data collection and quality control.
- Administer data collection in the study areas that includes supervision, cross validation, quality control and data transcription.
- Data management and analysis in terms of computer entry, cleaning, transcription, and analysis as per study themes in the objectives.
- Provide soft copy of data (both clean and unclean).
- Submit draft report of the study to Shiv Nadar University team prior to submission of final report.
- Shiv Nadar University will review the draft report and provide necessary feedback. The study team will submit the final report addressing the feedback received from Shiv Nadar University
- Prepare list of works to be carried out as per the identified infrastructural gaps
